Dear Parents/Carers,

At St George's Catholic School, we aim to promote personal and emotional wellbeing through a comprehensive taught programme called SCARF. SCARF perfectly connects the pieces of Personal, Social and Health Education, emotional literacy, social skills and spiritual development into an easy to use lesson-a-week programme. This gives our pupils the knowledge, understanding, attitudes and practical skills they need to live healthy, safe, productive and fulfilled lives, both now and in the future.

As you may already be aware, the Department for Education has announced changes to relationships and sex education (RSE) following a nationwide consultation. These changes were supposed to come into effect from September 2020, but due to current circumstances and unprecedented times, they will be fully in place by the Summer Term 2021. The statutory guidance can be found on our school website. Details on how to access all materials related to our RSE consultation are given at the end of this letter.

The new RSE guidance focuses on healthy relationships and keeping children safe in the modern world. It covers a wide range of topics relating to physical and mental health, wellbeing, safeguarding and healthy relationships. Learning about the emotional, social and physical aspects of growing up will give children and young people the information, skills and positive values to have safe, fulfilling relationships and help them take responsibility for their own wellbeing. Therefore, from the Summer Term 2021, Relationships and Sex Education, along with Health Education, will be statutory and form part of the National Curriculum.

The Senior Leadership Team, together with Governors, have been reviewing our RSE curriculum and identifying in what subjects we teach certain areas of RSE to ensure that our provision is appropriate for all our pupils based on their age, physical and emotional maturity, religious and cultural backgrounds, special educational needs and disabilities. Details on how to access all materials related to our RSE consultation are given at the end of this letter.

Whilst there may be slight differences of opinion on the teaching of RSE, we hope that consulting with you will help to inform our school's decision making process and enable us to reach a consensus. Consequently, as part of our curriculum review we would like to hear your views on:

- Our draft policy for Relationships and Sex Education (RSE)
- How certain content within this subject is covered.

What is taught, and how, is ultimately a decision for the school as we are legally required to teach the National Curriculum. However, we value and are keen to hear your insights. The right to withdraw children from some lessons is explained in the FAQ document from the Bishop's Conference, which accompanies this letter. To help you to understand the curriculum and to consult with you, we have placed information on our website which we would encourage you to read. This includes:
